

RESOLUTION OF THE CALL FOR MEDIATION PROJECTS

On the 30th of April 2024, the *Mediation projects* announcement of residencies was published on Tabakalera's website through the Education / mediation department with the aim of supporting and sustaining the development of significant mediation processes, as well as discursive and methodological research in the field of mediation, which accompany and complement the work being carried out by the Tabakalera Education area.

In compliance with that stipulated in section 5 of the aforementioned Terms and Conditions, a Commission was constituted consisting of Clara Montero Tellechea (Cultural Director of Tabakalera CICC), Betisa Ojanguren San Millán (manager of Education at Huarte zentrua), Nerea Hernandez Serna (coordinator of Education at Tabakalera CICC) and Itziar Imaz Ganzarain (manager of Education at Tabakalera CICC) to assess the Parts that comprise the Open Call.

The Commission having evaluated the projects presented on time and in compliance with the criteria established in the Terms and Conditions for selecting projects opting for residence, as proposed by the aforementioned Commission, the Managing Director of CICC/Tabakalera

HAS DECIDED TO

One.- Select the projects presented by the individuals listed on the table included as Annex I to participate in Mediation Projects of the Open Call according to the terms included in the Terms and Conditions thereof.

Two.- Provide the following grants to each of the projects selected:

1. Residence for mediation process

1. 10,000 euros plus the corresponding VAT, as fees, which will be paid by invoice. A deduction will be applied to this amount depending on the tax situation of each resident. The corresponding documentation will be requested for this purpose.

2. A sum of 4,000 euros (excluding taxes and deductions) for production and other costs associated with the

4,000 (excluding taxes and deductions) for production and other expenses associated with the process. This amount will also be paid by invoice, on presentation of a budget. For this purpose, the corresponding documentation will be requested. The residency does not include accommodation.

2. Residence for research in mediation

1. 4,000 euros plus the corresponding VAT, as fees, to be paid by invoice. A deduction will be applied to this amount depending on the tax situation of each resident. The corresponding documentation will be requested for this purpose.

2. 1,500 euros (excluding taxes and deductions) for production costs and other expenses associated with the process, such as travel, allowances, etc. This amount will also be paid by invoice, on presentation of a budget. The residency does not include accommodation.

For both modalities:

3. Work space in Tabakalera artists' space, equipped with basic furniture, electrical socket and lighting.

- 4. Access to the office and common areas.
- 5. Access to Tabakalera's specialised creation library and Medialab resources.

6. Access to image and sound editing studios, set or space for stage practices and audiovisual resources on loan.

7. Technical resources and assistance from the Tabakalera team, according to needs and availability.

8. Conceptual accompaniment in the development of the project by the Education Department, as well as assistance and help for its introduction to different agents and projects in the context if required by the resident.

Three.- Publish this Resolution on the website of the Centro Internacional de Cultura Contemporánea, S.A. and provide notice thereof to those selected.
