

RESOLUTION OF THE CALL FOR TABAKALERA-CHILLIDA LEKU. ART AND LANDSCAPE RESIDENCY 2024

On 12th, February, 2024, the Tabakalera – Chillida Leku. Art and Landscape residency 2024 open call was published on Tabakalera's website through the art department with the aim of developing an artistic residency between Chillida Leku - (Hauser & Wirth San Sebastian) and Tabakalera - International Centre for Contemporary Culture, in San Sebastian.

In compliance with that stipulated in section no 4 of the aforementioned Terms and Conditions, a Commission was constituted consisting of Ane Agirre (Tabakalera), Laida Mendia (Tabakalera), Mireia Massagué (Chillida Leku) and Nausica Sánchez (Chillida Leku) to assess the applications received in the Open Call.

The Commission having evaluated the projects presented on time and in compliance with the criteria established in the Terms and Conditions for selecting projects opting for the residency, as proposed by the aforementioned Commission, the Managing Director of CICC/Tabakalera

HAS DECIDED TO

One.- Select the project presented by the individual listed on the table included as Annex I to participate in Tabakalera – Chillida Leku. Art and Landscape residency 2024 according to the terms included in the Terms and Conditions thereof.

Two.- Provide the following to the project selected:

- 1. Return journey from the artist's place of residence or from the place where the artist is located just before the residency, at the discretion of the successful bidder.
- 2. Medical insurance during the residency period.
- 3. Fully furnished apartment (kitchen, bathroom and bedroom with a small work area and an internet access with WiFi), at Tabakalera.
- 4. Work studio in the artists' space in Tabakalera. For this purpose, Tabakalera has studios with a variety of features equipped with basic furniture, a nearby water supply, electrical power, lighting and internet access with WiFi. The studio will be assigned taking into account the characteristics of the selected project.
- Access to all the resources of Tabakalera as well as to the collections and resources of Medialab.
- 6. Access to Chillida Leku's facilities throughout the entire duration of the residency.
- 7. €2000 (€1000 for each month of the stay, excluding taxes and withholdings) for allowances and expenses during the 8 weeks of the residency.
- 8. Funding up to a maximum of €1500 for developing the project within the framework of the residency, after the presentation and approval of the budget.
- 9. Conceptual and artistic support in the project's development as well as assistance and aid with its introduction to different agents and projects of the context, if so, required by the resident.

Three.- Publish this Resolution on the website of the Centro Internacional de Cultura Contemporánea, S.A. and provide notice thereof to those selected.
